NTC 25/83 OPEN FORUM

Richard George introduced himself to the Council and confirmed that he has made a formal request to the CWaC Monitoring Officer regarding his allegation for NTC's withholding of material. He also raised an additional question about which organisation is funding the legal fees regarding potential changes to Verdin Park, and under what legal authority is permitted to do so? If it is the Mid Cheshire Hospitals NHS Foundation Trust, then the Council should confirm that no benefit, right of use, concession, licence, or land access agreement is being negotiated in exchange for this funding and provide clarity on whether this represents a direct financial interest in land held on statutory trust for public recreation. Mr George also queried why NTC are spending money on expensive barristers, which is in addition to the questions already submitted by email. NTC are currently awaiting the Monitoring Officer's response. Richard George confirmed he will be submitting a further request to Chris Shaw by email and will receive a reply in due course.

Katie Astbury reported that she had emailed the Chief Officer earlier in the week regarding the barrister engaged by the Council and the issue of this being funded by NTC. She noted that she had been informed her response would be deferred pending a reply from the Mid Cheshire Hospital Trust.

Ms Asbury asked on what basis NTC had acted at the time the Chief Officer enquired about potential funding from the Mid Cheshire Hospital Trust for the barrister. Ms Astbury advised that, during the past week, she had received formal confirmation by email that a barrister has engaged to review matters relating to Verdin Park. She further reported that she had been told a full response would only be provided once clarification had been received from the Mid Cheshire Hospital Trust regarding their funding position.

Ms Astbury reported that information received during the week indicated that the barrister would be funded by the Mid Cheshire Hospital Trust. She noted that she had previously requested clarification on the matter but had been advised that confirmation could not yet be provided. Ms Astbury expressed concern that this ongoing uncertainty could undermine confidence in the Council's decision-making.

Cllr Kent asked for clarification, and Ms Asbury reiterated that the situation gives her no confidence in the Council. She asked why the Mid Cheshire Hospital Trust is funding the barrister and stated that she believes NTC holds the relevant information but that it has not been provided to her.

Cllr Waterman asked the Deputy Chief Officer to clarify the query raised by Ms Astbury regarding the seeking of legal advice. The Deputy Chief Officer reported that the Mid Cheshire Hospital Trust had confirmed they would be funding the barrister. It was further noted that this matter had been recorded in the minutes, with a recommendation that NTC seek additional legal clarification.

Ms Astbury further clarified that the Mid Cheshire Hospital Trust would be paying for a barrister to obtain land clarification in relation to their proposed car park, specifically to determine whether a car park can be constructed on the site.

Cllr Guy asked where the social media information had been seen. Ms Astbury advised that she did not wish to name the Councillor who is present in the room. Cllr Guy noted that the information had only come to light after last month's Council meeting. She emphasised that if something has appeared on social media, it is important for Northwich Town Council to take appropriate action.

It was noted that discussions have taken place since the last meeting and that the Council remains in ongoing discussions with the Trust. Further discussion and agreement will be required going forward.

Councillor Fox confirmed that due diligence had been undertaken regarding the issue raised with the Council and the Trust concerning ownership. She clarified that the Council is not responsible for building the car park and has sought appropriate advice. Councillor Fox stated

that the lease is not being taken out by the Council, and it should be the Trust's responsibility to fund the necessary legal advice to ensure all requirements are met. The Town Council's intention is to protect itself and comply with any legal obligations.

Mr George asked if Councillor Fox was legally trained. Councillor Fox confirmed that she was not but noted that she has experience in planning and is familiar with the relevant procedures.

Councillor Kent commented that the Chief Officer, on behalf of the Council, had initially indicated that there were no impediments to continuing discussions with the Hospital Trust. Council members acknowledged that challenges have arisen and confirmed that further specialist legal advice is being sought before any further action, at no cost to the Council.

Councillor Kent noted that some councillors contribute to social media and have observed repeated statements that are untrue or contradict previously stated points. He emphasised that the Council is acting in the best interests of the town and will continue to monitor the situation.

Mr George commented that Councillor Kent is incorrect as he believes that NTC has offered to build the car park themselves and it isn't black and white as Councillor Kent has said.

Ms Astbury expressed appreciation for Northwich Town Council's openness. She highlighted that it is significant that Mid Cheshire Hospital Trust is unable to fund legal advice. Referring to Mr George's earlier comments, she noted that there is often considerable pushback from residents, who do not understand why Verdin Park would be considered for use.

Councillor Fox asked about the source of the legal advice. Ms Astbury clarified that the advice came from her daughter, who is a specialist lawyer. Councillor Fox thanked Ms Astbury for the clarification.

NTC 25/90 **REDUCTION IN PCSO'S**

Members received a report on the reduction in PCSO's and this included a letter from Dan Price, the Police and Crime Commissioner.

Councillors will respond to the letter, Councillor Stewart commented that the police deal with crime but the PCSO get involved with the community who part of there role is going into schools meeting with the pupils but respects the decision.

Councillor Guy has already wrote to the Cheshire Constabulary and the PCC and has copied in our MP Andrew Cooper and has asked a series of questions what the process is and what is the impact and what will happen to PCSO and what does the saving look like for neighbourhoods.

Councillor Cernik has had different experiences with PCSOs and some have been fantastic and have demonstrated great staying power and has done great work with young people to address ASB. Some PCSOs do come and go and go on to join the police, PCSO really do contribute to the local areas.

NTC will invite Dan Price to a future council meeting.

Councillor Kent is interested in what the PCC response will be back to Councillor Guy and is concerned on the impact it will have in our area.

Councillor Parkes commented that this is a great shame in losing PCSOs.

Councillor Guy felt for a PCSO who has contacted her and is concerned about his future with the Police. They have a wealth of knowledge and are part of the community neighbourhood and wants to know the process of the decision.

Councillor Naylor commented that the decision came out of the blue and sits on the PCC panel and has always valued the contribution that PCSOs delivery as they are the eyes and ears of community and was involved in the first recruitment selection of PCSO. Police and Councils, NHS they have all been hollowed out and the funds are not there to provide services that we need. We need to get a better assessment to see what is being proposed and what the PCC response will be as we might get more police officers.

Councillor Cernik would like to make a proposal and invite Dan Price, PCC to see what the rational is then write to the Cheshire Constabulary for further decisions. Also invite the Chief Inspector Leeroy to inform us what the plan is.

NTC 25/91 PROPOSED CW&C COUNCIL LICENCE FEES

Members received a report from the Chief Officer regarding the proposed Cheshire West & Chester (CWaC) Council Licence Fees.

Councillor K. Cernik asked whether Northwich Town Council (NTC) had previously paid a licence fee. The Chief Officer confirmed that NTC had not, although other councils do.

Councillor Fox asked who would be responsible for paying the electricity costs. The Chief Officer explained that Scottish Power would invoice NTC, and she queried whether there were any legal reasons for this arrangement.

Councillor Waterman asked why the fees were being introduced and whether there was justification, expressing concern that they could be detrimental to the town centre.

Councillor Fox noted her experience with CWaC and questioned why fees were being applied in some areas but not others, asking specifically why Ellesmere Port and Chester, which are not parished, do not pay similar fees.

Councillor K. Cernik asked about fees for events. The Chief Officer confirmed that these fees were reasonable, as an event plan would be reviewed by the Safety Advisory Group (SAG) before a decision is made.

Councillor Kent questioned how such decisions could be made without consultation with affected parties.

It was proposed that NTC write to CWaC Council highlighting the potential impact and possible loss of events if these charges are imposed. The Council will seek further clarification and invite Councillor Bingham and Charlotte Walton, the lead CWaC Senior Officer, to discuss the matter.

NTC 25/92 OUTSIDE BODIES

Councillor Kent updated members on the Community Rail Partnership. He reported that traffic on the Mid Cheshire Line increased by 14% in October, which is very encouraging. Cancellations have decreased; however, new trains will not be introduced until 2030. Punctuality stands at 86%, and Sunday services continue to be affected by the longest industrial dispute in the country. The ticket office is scheduled to transfer to Northern Rail this month.

Councillor Kent also raised concerns regarding the deteriorating condition of the building owned by CWaC, describing it as a disgrace. He proposed that Northwich Town Council write a short letter to CWaC Properties to seek accountability for the building.

Councillor Cernik reported on her attendance at the Community Care Partnership. She recently attended an event with Home Instead and noted that the monthly Dementia Friendly Group meetings continue. She expressed a desire to work with BID Northwich and local businesses to promote Dementia Awareness and to see the Dementia Bus return to Northwich for further awareness sessions.

It was proposed that NTC write to CWaC Properties requesting an explanation regarding the condition of the building.

Councillor Neil reported that S106 funds are to be allocated to Hunts Lock to improve functionality, restore railings, and refurbish the footpath. He also noted that Saxons Lane has submitted new plans and an Asset of Community Value (ACV) application for Navigation Road.

Councillor Waterman provided an update on an event for Cheshire Central, formerly the Mid Cheshire Board/Partnership, highlighting that it presents an opportunity to create positive regional change.

Councillor Naylor reported that he has been covering Councillor Deans' casework and sent his best wishes for her recovery. He confirmed there are no asylum hotels in Northwich and commented on the work of the Fact Not Fiction team. Councillor Naylor has also been involved in matters concerning contaminated land in the area.

Regarding Weaver Square, presentations were received from VINCI and ION, who will be consulting on developments in the area. Councillor Naylor emphasised the importance of public and councillor input and noted an opportunity for up to 10 interested parties to join a consultation board.

He also updated members on flooding issues, noting that the government has allocated £50 million. VALOUR is exploring ways to engage with veterans to ensure they receive necessary support. Councillor Naylor mentioned involvement with LSEP, which will provide employment opportunities. He also noted a guided tour of the library by Sir Hugo Brunner from Oxford, who intends to return for the library opening, which will be a significant addition to the town centre.

Councillor Guy asked about the start date for the incinerator. Councillor Naylor confirmed that cold testing will begin in 2026, with full operation expected by April 2027. Councillor Guy asked if the community would be informed of any breaches, and Councillor Naylor confirmed that a community response will be provided as per the planning application. Councillor Naylor also extended an invitation for any members wishing to visit the site.

Northwich Infirmary Update

Our solicitors are now in receipt of all the information/deeds/leases/convenances in relation to Verdin Park, these documents have also been uploaded to our website for the public to view if they wish. Once we have received the advice from our solicitors, we will be able to address the challenges we have received and respond accordingly to residents concerns.

Electric Vehicles

Northwich Town Council have started the process of reducing its diesel vans, with electric vehicles, we have already replaced two vehicles which will be used for play inspections, funerals and site visits. Two more vehicles are on order which will be used for watering in the summer and local works in and around the town centre and parks throughout the year. We will still need to keep one large vehicle due to longer distances travelled and towing capacity.

Summer Bedding Schemes

We will be working with Rupert Adams and local schools to install pollinating plants into our existing bedding displays, we will be working to create a corridor for butterflies and other insects to thrive around the town centre. Verdin Park and Vickersway Park will see additional wildflower areas installed along with the amazing display that is planted each year in Witton Cemetery.

Police Christmas Event

Northwich Town Council in partnership with Northwich BID supported the Police Christmas Event with a donation of prizes for the local young people nominated.

Tree of Lights

This annual event took place on Friday 12th December and was again very well attended. Many thanks to our staff and local businesses who supported the event. Thank you to Father Paul and Cannon Diane Vickers for delivering the service.

Budget Setting

We are currently working on our budget for 2026/27 which will see us once again delivering events throughout the town, fantastic floral displays, modern well-maintained parks, play areas and cemeteries along with allotments, Christmas lights and cleansing.

As a Council we need to adapt all the time, introducing new events, looking at ways of saving money by becoming more efficient in how we deliver our services, making difficult decisions when needed to but still delivering the same high-quality service that Northwich Town Council is renowned for.

This year's budget which will be submitted to Finance in January for approval at Full Council in February.
