

Under Chapter 7 of the Localism Act 2011 and the authority's Code of Conduct, Members must register a) their Disclosable Pecuniary Interests and b) Other Disclosable Interests.

Disclosable Pecuniary Interests are defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 as set out in the categories in Part A below. In Park A, you are required to give notice to the Monitoring Officer of YOUR interests (i.e. you, the Councillor) and those of YOUR PARTNER (which means spouse or civil partner or a person with whom you are living as husband or wife, or as if you are civil partners) where you are aware of your partners interests.
